Update on our numbers:

We are in the process of transporting 54 residents to Heritage Hall Blacksburg. Several trips will be made. We are also in the process of transporting 20 residents to Rural Retreat - 2 trips. 6 are being sent to Blue Ridge Therapy Connection - 4 of which are memory care. 1 memory care to Abingdon. 5 will be sent to the Virginia Veteran's Care Center. 10 are being sent home. And now 4 will be sent to Liberty

Ridge.

EOP activated, administrator is incident command. Our facility is not able to care for residents that are Covid-19 positive, and we do not have a memory care unit. Staff state important pieces of information to note during a potential influx of new residents is face sheet information to have responsible party contacts, medications present, admissions ready to take photographs with name labels to identify residents, rooms labeled with appropriate names to ensure enough space, physician orders - to know about dietary orders and medications for example, a system to sign off with the transporters bringing residents to our facility for accountability, a means to do head to toe assessments upon arrival, and a means to have consent to treat documents signed and Covid 19 tests upon arrival. Will provide more information as staff provide input.
